TREE REMOVAL Application Checklist

Please note: You may remove "As-of-Right"

One tree per each 10,000 square feet of lot size per each two-year period, but may not exceed eight trees in any two-year period or twelve trees in any six-year period.

Definition of a tree:

4" or more in caliper measured at the point of maximum width at 4 feet from the ground.

No tree this size or larger may be removed without first obtaining a permit

The following information is required if you wish to remove trees as per the **Village of Montebello's Tree Preservation Law, Chapter 176 of the Village Code:**


- **Complete Application.** Application for removal will not be accepted unless all the below documents/photos are submitted.
- **Copy of your property survey** depicting with an "A, B, C the approximate location of each tree(s) to be removed. If you do not have a copy of your survey visit village hall and look in your property file, there may be a copy.
- **Marking of Tree(s).** Trees requested for removal must be easily identifiable (i.e., ribbon, paint). The Village Engineer **may** do an on-site inspection.
- **Estimate** from the Licensed Tree Removal Contractor indicating species, location and condition of tree. The information must mirror your application.
- The applicant shall note/mark any **dead, imminently dead or trees that are endangering public safety**. This report shall specify (as best as possible) species, size in diameter and condition or damages that qualify the tree(s) to be removed under these circumstances. If the tree is damaged then the submittal should identify the location(s) of the damage, if the damage is compromising the tree, and, to what extent. This information should be separate from the proposal and be as detailed as possible to assist in the review for tree removals under this category 176.6 (B) (2). In the event the Village Engineer cannot confirm the conditions or supplemental information is required prior to issuance of permit, the Village Engineer may request that the applicant submit a report prepared by an Arborist to support the request for the tree removal(s). If the tree contractor has an arborist on staff, they may include any opinions / documentation as part of the original submittal.
- **Photos:** the report may be submitted hard copy or electronically to the Village as long as information is provided and detailed. If the applicant chooses an electronic submittal all photos shall be labeled with descriptions.
- **Fee:** if applicable, there is a \$10.00 fee for dead tree removal, regardless of how many are being removed.

This process may take up to 10 days from the time a completed application is submitted – Please do not schedule an appointment for removal until "APPROVED" permit is received.

A copy of the approved permit will be mailed, faxed or emailed to both the homeowner and the Tree Contractor.

Original signatures on this application are required.

Any person violating any of the terms or provisions of this chapter or refusing to comply with the rules and regulations of this chapter shall, upon conviction, be subject to a fine not exceeding \$250 for each offense. Each tree that is cut or damaged without appropriate approval from a Village agency shall constitute a single offense, up to a maximum penalty of \$10,000 per lot.

Permission is granted in conjunction with tree removal application, to have the Building Inspector, Village Engineer, or designee for the Village, enter the subject property for purposes of inspection of the trees to be removed, or that have been removed, or of the work while in progress.
